#### Shri C.P. Jain

Shri C.P. Jain, aged about 71 years, is a Fellow Member of Institute of Chartered Accountants of India and holds Bachelor's degree in Law and Advanced Diploma in Management. He had a multidisciplinary illustrious career spanning over 43 years of outstanding professional contribution. He was Chairman & Managing Director of NTPC Ltd. during September 2000 and March 2006. For the period 2003-05, he had been the Chairman of the SCOPE Standing Conference of Public Enterprises the apex organization of Central Public Sector Enterprises (CPSEs) in India. Acclaimed widely for his vision across the spectrum of industry and business, he was awarded Ernst & Young's 'Entrepreneur of the Year - Manager Award 2005' and SCOPE's Award for the year 2003-04 for 'Excellence and Outstanding Contribution to the Public Sector Management-Individual Category'. He was President & CFO of Jaypee Powergrid Limited from 21st September, 2015 till 31st July, 2017 from where he resigned.
