Pursuant to Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements) Regulation 2015, this is to inform that the Company has been executing the Srisailam Left Bank Canal (SLBC) Project, also called the Alimineti Madhava Reddy Project, in the State of Telangana as a contractor. An unfortunate incident of collapse of roof of under construction tunnel took place at the said project on 22nd February 2025 as detailed below.

On 22nd February, 2025 between 10.00 A.M. to 11.00 A.M., the work was going on at utmost care and about 60 workmen including engineers, technicians, operators and Tunnel Boring Machine (TBM) in-charge were at location and TBM was doing its work when the in-charge of the shift observed sound and intuitively ordered evacuation and ran for safety as huge amount of water, stones, sludge and mud came down from the roof and filled the entire area in length of about 300 meters. Unfortunately, when the headcount was taken, 8 workers which includes 2 officers have got trapped in the debris. With the response team, medical team and support of departmental officers, district administration, efforts have been going on to retrieve the trapped workmen and officials.
