

Expression of Interest for (i) Drilling Services & Material Supply , (ii) Geo-chemical Survey for Oil & Gas exploration / development of SR-ONN-2004/1 onshore Block in South Rewa Basin, Madya Pradesh,India (EOI No. PPCL-JAL/SR/EOI/01/2010)

The consortium comprising of Prize Petroleum Company Limited (PPCL) and Jaiprakash Associates Limited (JAL) were awarded the SR-ONN-2004/1 Block in South Rewa Basin in Madhya Pradesh under NELP VI round of bidding by GOI. At present 2D and 3D –API works are under execution and scheduled to be completed before end 2010. PPCL-JAL propose to commence its drilling campaign by around Feb/March 2011. The campaign includes drilling of 3 exploratory wells upto a maximum depth of 4000 meters. Pursuant to identifying areas of interest after the 2D-3D API , PPCL-JAL also propose to carry out Geo-chemical survey around Jan/Feb'2011.
